AABHN PLAYING REGULATIONS

BOYS BASKETBALL

All coaches must be familiar with the content of the AABHN Constitution.

- 1. Start Date November 1
- 2. <u>Length of Season</u> November 1 to OFSAA
- 3. **Competition Limits**: 30 games including tournaments. 1 tournament counts as 2 games.
- 4. Members per Team 15
- 5. Eligibility

All players must meet the eligibility criteria as outlined in Article 12 in the AABHN Constitution

6. Eligibility Lists

a) Submission

A completed and correct OFSAA Hub eligibility lists must be submitted to the convenor and Athletic Coordinators one week prior to the start of the regular season for each District. The names of all potential players and coaches, and managers and/or others affiliated with a team must be included on the OFSAA Hub eligibility list. Each eligibility list is to clearly identify the head coach.

7. League Structure

- a) Double Round Robin (home and away).
- b) Each school to provide their own balls for warm-up.
- c) Game times to be set by host school in communication with the Convenor.
- d) Should there be a need for a change in start time, it must be negotiated by participating schools. The Convenor/Athletic Co-Ordinator should be notified of the change.
- e) Game Sheets/Score Sheets The Home team is responsible for supplying the score keeper, timekeeper, shot clock operator, score sheets, and game ball.

8. Game Results -

- i) The home team must forward an original or electronic copy of the game sheet to the Convenor no later than the day following the game.
- ii) The host school coach will provide the game results including top scorers to the media (e.g., newspaper, radio).
- iii) The Convenor will maintain and update the league standings.

9 Championship Structure

- i. The home team for all play-off games shall be the team with the highest standing following regular season play.
- ii. Playoffs will consist of Quarter Finals, Semi Finals and Finals. Playoff format will be determined based on the number of schools participating in each league. Refer to Constitution for formats regarding an even and odd number of teams in a league. iii. All play-off games will be a one (1) game sudden victory format.
- iv. Start Times all times should be mutually agreed upon by both participating schools
- v. Quarter Final games will be played at the site of the higher standing team during regular season play.
- vi. All semifinals to be played at the location of the highest standing remaining team.
- vii. All finals to be played at the location of the highest standing SENIOR team (both Junior and Senior Finals to be played at the same location).

10. Tie Breaking Procedure:

Where a tie exists in league standings: The tie will be broken by:

AABHN Tiebreaker

Application of Sport Specific Tiebreakers In the event of a tie in League/Division Standings at the conclusion of scheduled league play, the following criteria shall be used to determine final standings:

- 1. Record (win/loss) between/among tied teams in head-to-head competition.
- 2. Point differential between/among tied teams in head-to-head competition.
- 3. least points against involving the tied teams in the game they won.
- 4. the most total wins during season play.
- 5. least total points against (all games played).
- 6. Point differential (all games played)

Scored in the games played to the maximum allowed for each sport as listed below: Maximum Points Per Sport: Baseball -7 Basketball - 20 Field Hockey - 5 Volleyball - 15 - if # of sets won does not break the tie. Lacrosse - 8 Football - 21 Hockey - 5 Rugby - 20 Softball/Slow Pitch - 7 Soccer - 3 Curling - 6 Ultimate - 6

7. Coin toss

Tie Breaking Procedure When three (3) or more teams are tied, the order of tiebreaking, as outlined above, is applied until one or more team(s) are separated from the tied group. The tie breaking process will then be repeated starting at #1 for the remaining tied teams. This process will continue until all ties are broken.

How to determine the 2 AABHN Play-in representatives FOR CWOSSA

The 2 teams in the league that go furthest in the playoffs.

To determine the second team, if two teams finish in the same position in the playoffs (ie: lose in the semifinal), seeding will be determined by placing at the end of the regular season.

11. Officials

i. Officials will be contacted by the Athletic Co-ordinator. ii.

A game can be played with 1 Official if both coaches agree.

12. Rules of the Game

- a) The current FIBA Rule Book shall govern play with the following exceptions:
- i) A thirty-five (35) second shot clock will be used. Full reset on foul shot attempts and shots off the rim.
- ii) Fouls and offensive rebounds will result in the thirty-five (35) second reset.
- iii) In lieu of the shot clock the "closely guarded five (5) second rule" will be implemented by referees if delaying the game is used as a strategy by the offensive team.
- iv) National Federation lines will be used even when FIBA lines are available.
- b) An identified OCT member employed by the Board must be on the bench throughout the duration of all games where a community coach/non OCT member is involved as the head coach.
- c) A team in deficit of thirty (30) points or more may request running time, to be agreed upon by both teams.
- d) Any player or coach who is ejected from a game competition or accumulates three (3) technical fouls during the league season including play-offs will automatically be suspended form his or her next AABHN league game, be it regular season, play-off, CWOSSA or OFSAA event. After suspension, should any player or coach be ejected or accumulate two additional technical fouls he or she will be automatically suspended from his or her next two (2) AABHN

league games be they regular season, play-off, CWOSSA or OFSAA. Any further ejections or technical foul after two (2) suspensions would result in suspension for the remainder of the league season including regular season, play-off, CWOSSA or OFSAA. Coaches are required to report all ejections and technical fouls to the convenor within 24 hours of the competition.

13. Finances

- a) Those schools having entries in the regular season will split costs evenly. Fees will be paid by the Association.
- b) All schools making playoffs will pay bases on a per game cost basis.
- c) Costs for finals will be split evenly among all league participating teams if gate is collected.

14. Awards

a) Team trophy for the league champions.
